



1. Preliminary remark:

Welcome to the STRANDPARX cable island. The car park is operated by Carsten Böhlecke.

The pitch is equipped with electricity columns, a water supply and rubbish disposal station. There are also toilet and shower blocks, baths for hire and a dog beach on site.

To make your stay as pleasant as possible and to ensure that everything runs smoothly, we ask you to observe the following rules. The use of this pitch constitutes a contract subject to the following conditions. Users recognise these pitch rules.

2. Use

- When you arrive, please register at reception immediately, even if you are only staying for a short time.
- **Access** to the Caravan Area is only permitted to **users of the caravan park** between 8am–8pm. Outside of this time window, our own car park is available 24/7 at the "stop over" rate.
- **The caravan area is primarily intended for motorhome owners.** However, it also offers space for motor vehicles, caravans and tents by prior arrangement. The erection of awnings is not permitted. **Unauthorised vehicles or tents will be removed for a fee.**
- All **pitches are subject to a charge.** The pitch fee must be paid on the day of arrival or via the online booking. The ticket/voucher must be clearly visible in the motorhome.
- **Visitors** must leave the pitch/grounds by 10 pm unless they have been registered for overnight accommodation. **Persons** found on the campsite **without valid proof** of registration (e.g. receipt) will be **charged double the price shown.**
- **Children and young people up to the age of 17** can only stay overnight with us if they are accompanied by parents, teachers or other **supervisors.** Young people up to the age of 18 require written authorisation from their parents or guardians.
- **Please avoid any soiling** of the pitch and its surroundings. Waste must be separated and disposed of in the waste bins provided. Only waste and recyclable

materials that accumulate on the campsite may be disposed of. **The disposal of waste, rubbish or bulky waste brought onto the campsite is not permitted.**

- The **supply** (fresh water) and **disposal** (wastewater) is **carried out exclusively via the supply and disposal system**. The chemical toilets may only be emptied at the designated point. Waste water from the operation of the mobile homes may only be emptied into the drain provided for this purpose at the disposal station. **Wastewater must not be released into the environment**. Under no circumstances may waste water be disposed of on lawns or in the lake. **Washing vehicles on the pitch is prohibited**. The perpetrator responsible is fully liable.
- The **use of generators is prohibited**. If you need electricity, please use the existing electricity columns.
- The **operation of sound systems is prohibited**.
- **Order and cleanliness are an obligation for all users of the motorhome site**. All facilities and equipment must be treated with care. The pitch must be left clean after use. Any rubbish can be disposed of free of charge in the bins provided. Please use our containers near the entrance.
- Cleanliness is of great importance. Leave the sanitary facilities as you found them. Children under the age of 10 may only enter the shower and wash-up blocks when accompanied by an adult. Crockery and laundry may only be washed in the designated areas.
- **Pet owners** must ensure that other pitch guests are not disturbed. **Dogs of all sizes must be kept on a lead at all times. Dog walking is only permitted outside the grounds**. Please dispose of dog waste immediately in the waste bins provided. **Any offence will result in immediate expulsion from the grounds without exception and without reimbursement of all payments/costs already made.**
- **Pets are allowed to run free on the designated dog beach**. The rules for pet owners apply here. Check the homepage: www.strandparx.de
- **Parents are responsible and liable for any damages** caused by children to any facilities on the site. There are several playgrounds and attractions on the premises and in the water. **Parents are responsible for the supervision of their children**.
- Designated areas are available for sports activities such as ball games or similar (see signposts or check the notice boards, reception, ticket office). Please only use these areas.

- Enclosing the pitches with **fencing is prohibited**. The pitch must be completely tidied up by the user before leaving. It is prohibited to block pitches.
- As you would certainly also like to have a well-kept lawn, it is **not permitted to lay out air-impermeable tarpaulins or carpets**.
- **The use of trailer lifting jacks is strictly prohibited on green spaces.**
- **The emptying of grey water is strictly prohibited on green spaces.**
- The pitch may only be used by **vehicles with liability insurance and registered/authorised vehicles**. Use and driving on the site is at your own risk. **The maximum speed limit is 10 km/h.**
- The camper is obligated to take out at least one liability and fire insurance policy for his property and to present it to the campsite management on request. No liability is accepted for accidents, injuries and lost property. The safety regulations according to the operating instructions regarding liquid gas, electrical energy and the equipment used must be observed. Open fires of any kind are not permitted.
- The supervised use of a barbecue is only permitted on hard standing pitches without exception. Barbecues **on the lawns and the use of ground barbecues are strictly prohibited**. Any nuisance to other users caused by fire, flying sparks and smoke must be avoided. **Fire extinguishers are compulsory on all pitches!**
- **The Caravan Area is accessible between 8.00 am and 8.00 pm.** The barrier does not open automatically outside these times. Arriving vehicles can park in the **car park in front of the site** as well as in the **waiting area**. **Exit outside the barrier opening times is possible on request.**
- Please be considerate of other guests and neighbours and avoid disturbing noise. In particular, **the nighttime noise curfew must be observed from 10.00 pm to 7.00 am**. Always turn down the radio, television, etc. so that you do not disturb others. Fireworks and firecrackers are prohibited on the pitch and must not be set off.
- Please note that the areas around the trees harbour certain risks due to falling leaves and branches; **we accept no liability for this.**
- **The site is unguarded.** Any claims for damages against the operators are excluded.
- To maintain order and safety on the STRANDPARX cable island site, in particular in the caravan area, it is forbidden to carry on a business or engage in any kind

of sales or exhibitions of products; exceptions are permitted by the operator of STRANDPARX cable island.

- **The operator is authorised to exercise domiciliary rights** to refuse to admit persons and to expel persons from the site if this appears necessary to maintain safety and order on the motorhome site and in the interests of the guests on the pitch. The **instructions of the operator's personnel must be followed without discussion**, in particular with regard to the positioning of vehicles.
- **Please check out at reception before departure.** Departure must take place by 10 a.m., otherwise we will charge an additional day.
- **You are staying with us in nature and under trees**, which are regularly inspected, but please understand that we will not be liable for damage caused by falling branches.
- **Entering or travelling on the STRANDPARX site, accessing the lake** at the designated beaches and **using the water areas is always at your own risk.**

By parking your motorhome, caravan or similar, you accept our site regulations and fees. All fees can be found in the current price list.
